Norfolk Southern: Changes to Tier 1 & Tier 2 Facilities Free Time

Norfolk Southern recently issued the following announcement:

Effective December 7, 2020 NS Croxton & Erail terminals will be added to the list of intermodal facilities categorized as Tier 1 while Cincinnati & Kansas City will be categorized as Tier 2 for domestic equipment. Domestic shipments grounding at Tier 1 facilities receive a free-time allowance of Day of Notification plus one free day. Domestic shipments grounding at Tier 2 facilities will receive a free-time allowance of Day of Notification plus two free days.
